Notes to financial statements for the Year ended March 31, 2016

NOTE 1: CORPORATE INFORMATION

CAE Rossell India Limited was incorporated on June 7th, 2008 under the provisions of the Companies Act, 1956. The company is engaged providing maintenance and training solution for high fidelity aintenance and training solution for high fidelity and simulation for all the maplatforms being acquired by three Indian Defence Services.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

a. Basis of preparation
